The Daniels Family Papers include the papers and accounts of Eliphalet, Joseph, George and Joshua W. Daniels of Portsmouth and Durham, New Hampshire. The papers include correspondence, receipts, probate records, legal papers, and legal certificates. One volume of accounts belonging to Eliphalet Daniels covering the period from 1765 to 1787 is also included. This volume supplements a previous accession of Daniel's Family account books.
