#### **Abstract:**

The Lane Family Papers, 1727-1924, contains the papers of various members of the Lane Family from the eighteenth, nineteenth, and twentieth centuries. Materials in the papers include diaries and journals, ledgers, accounts, correspondence, legal papers, and other personal papers belonging to members of the Lane family.

### **Acquisition Information and Provenance:**

The materials in this collection are composed of a number of different accessions. Much of the material is believed to have been donated in 1914 by Abby Lane of Stratham, NH. Henry C. Hines donated a journal kept by Deacon Joshua Lane in 1939 (M 1939.001). The majority of the genealogy materials as well as the background information on William Lane and the diaries of Samuel Lane were a gift of Priscilla Lane Moore Tapley in 1988 and 1991. The gift was made in memory of her mother, Esther Haynes Lane Moore Borg.

## **Biographical Information**

The Lane Family Papers, 1727-1924, contain materials from several generations of Lane family members from New Hampshire and Massachusetts. The earliest family member represented in the collection is Joshua Lane who lived from 1696 to 1766. Joshua Lane lived North Hampton, NH where he worked as a tanner and a shoemaker. He also was deacon of the church in Hampton, NH. In 1766, he was killed by lightning on his doorstep.

Two of Joshua sons are also represented in the collection: Isaiah Lane and Samuel Lane. Isaiah Lane lived from 1730 to 1815. He worked as a farmer and shoemaker in Hampton Falls, NH. Samuel Lane lived from 1718 to 1806 and was the oldest son of Joshua Lane. In 1741, Samuel Lane and his wife Mary (James) Lane moved to Stratham, NH where Samuel worked as a shoemaker, tanner, and surveyor. Samuel became deacon of the church in Stratham and also held various town offices including town clerk, selectman, and member of the legislature.

Samuel Lane's youngest son was Jabez Lane, who lived from 1760-1810. Jabez Lane lived on Samuel Lane's homestead and continued the work of his father. Jabez married Eunice (Colcord) Lane. Jabez's son Charles Lane lived from 1796 to 1884 and continued the family trade as a tanner and shoemaker. In 1817, he moved to South Newmarket, NH (Newfields, NH) where he sold shoes and leather and eventually groceries and dry goods. Charles moved back to his family's house in Stratham, NH in 1867 and remained there until his death.

Ebenezer Lane was the grandson of Samuel Lane (1718-1806) and son of Samuel Lane (1746-1820). Ebenezer Lane lived from 1771 to 1842. He attended Exeter Academy in Exeter, NH and worked as a teacher and then surveyor in Pittsfield, NH. He also served as justice of the peace and representative to the state legislature. George Lane was the son of Jabez Lane and lived from 1791 to 1883. He served in the War of 1812, as a town clerk, and as a representative to the state legislature. George Lane resided at the Lane Homestead in Stratham where he worked as a tanner and shoemaker. Edmund James Lane was also the son of Jabez Lane. He lived from 1802 to 1884 and served as deacon of the Congregational Church in Stratham, NH.

Materials of several other Lane family members are found in the collection including Lucy Lane (1805-1844), Amanda M. Lane (1823-1907), Olivia Lane (1825-1905), John William Lane (1827-1911), Charles E. Lane (1837-1868), Henry Lane (1831-1899), Edmund Barker Lane (1837-1924), Mary Haynes Lane (1827-1922), Abby Francis Lane (1846-1925), Anna Mathes Lane (1871-1932), Wallace Lane (1876-1946), and Esther Haynes Lane (1902-1978).

## Collection Scope and Content

### **Collection Scope and Content Note:**

The Lane Family Papers, 1727-1924, contains the papers of various members of the Lane Family from the eighteenth, nineteenth, and twentieth centuries. The collection is divided into two series: Series I. Lane Family Papers, 1727-1861 and Series II. Lane Family Papers, 1737-1924. The first series consists mostly of early family business and legal documents made through the mid-nineteenth century including ledgers, account

books, daybooks for stores, copybooks, and records of deaths. Series II. Lane Family Papers, 1837-1924 consists of the papers donated by Priscilla Lane Moore Tapley in 1988 and 1991. The second series contains genealogical manuscripts, diaries and journals, legal documents, correspondence, and personal papers of the Lane family from the eighteenth century through the twentieth century.

The Lane Family Papers, 1727-1924, are divided into two series:

Series I. Lane Family Papers, 1727-1861 Series II. Lane Family Papers, 1737-1924.

For the most part, the papers are grouped according to the creator and then organized chronologically. Types of materials in the second series include genealogical materials, diaries and journals, accounts, legal documents, correspondence, and other personal papers.
