#### Collection Overview

#### **Biographical Information/ Administrative Information:**

John McNeil was born on March 25, 1784 to John and Lucy (Andrews McNeil) of Hillsborough, NH. In 1797, he enlisted in the Army. McNeil was eventually promoted to Brigadier General in 1824 and Colonel in 1826 after service in both the War of 1812 and along the Western Frontier. From 1840 to 1850, he served as Surveyor for the District and Inspector of the Revenue for the Port of Boston, MA. McNeil married Elizabeth A. Pierce, daughter of Governor Benjamin Pierce and sister of future President Franklin Pierce, in 1814. Together, he and Elizabeth had four children: John W.S. McNeil, Elizabeth A.P. McNeil, Frances McNeil, and Benjamin P. McNeil. While serving as Surveyor for the District and Inspector of the Revenue for the Port of Boston, McNeil purchased the homestead of his father-in-law, Benjamin Pierce, in Hillsborough, NH. John McNeil died on February 23, 1850 while on a business trip to Washington, DC.

## **Collection Scope and Content Note:**

The John McNeil Family Papers, 1783-1874, contain correspondence and some legal papers and receipts related to John McNeil and some of his family members. The majority of the items in the collection are correspondence to and from McNeil, most of which is personal in nature. There is also some military related correspondence. There is personal correspondence between McNeil and his wife, Elizabeth Pierce McNeil and a few letters between McNeil and Benjamin Pierce. The collection also includes correspondence to McNeil's niece, Annie McNeil Wentworth, who was the daughter of Solomon McNeil and Nancy Pierce McNeil. This correspondence is mostly undated. Among the land deeds in the collection are some between McNeil and Benjamin Pierce concerning the property in Hillsborough, NH.
