New Hampshire in the Civil War Lesson Plan Analyzing Photographs: Henry P. Moore, New Hampshire's Civil War Photographer

Topic: Henry P. Moore, New Hampshire Civil War Photographer—Analyzing Photographs

Level: High School and Middle School

ABSTRACT / SUMMARY

The Civil War photographs of New Hampshire photographer Henry P. Moore provide a glimpse of regimental life and soldiers' experiences in the Confederate States. This lesson is a case study in analyzing and using photographs as historical documents while using the photograph primary source worksheet found on the Library of Congress website.

QUESTION / TASKS

Analyze the Civil War photographs taken by New Hampshire photographer Henry P. Moore in order to learn about life in the Civil War.

EXPECTED OUTCOMES

- Use primary and secondary sources to answer research questions
- Learn to use photographs as documentary evidence
- Learn about the life of a soldier during the Civil War

SEQUENCE OF ACTIVITIES

- 1. Use the Analyzing Photographs and Prints Worksheet found on the Library of Congress website.
- 2. Using a single Henry P. Moore photograph, walk through the worksheet questions as a class
- 3. Dividing the class into small groups of 2 or 3, repeat the exercise using a variety of Moore's photographs.
- 4. Research the photo processes used by Moore and others like him in the field. What did he have to do to make a photograph? Discuss in class as a whole, including imagining carrying the heavy equipment and setting up a darkroom for developing in a tent.

ASSESSMENT

Each student will fill out the Analyzing Photographs and Prints Worksheet for one of Moore's images and discuss the uses and limitations of photographs as historical evidence.
