The Hillsboro Guaranty Savings Bank was organized as the Hillsboro Bridge Guaranty Savings Bank in 1889. The word "Bridge" was dropped around 1922. The bank was purchased by the First National Bank of Hillsborough in 1960.

### **Collection Scope and Content Note:**

The Hillsboro Guaranty Savings Bank Records contain stock certificates issued, minutes of trustee meetings, correspondence and memos, and federal tax returns from 1889 to 1968.
