Abstract:

Amos Chase (1809-1884) was a manufacturer in Weare, NH; the company was called Chase & Drew and they made tanners' equipment. His son, John H. Chase (1837-1889) remained on the family land in Weare. Their papers are primarily about business and include legal papers, correspondence, accounts and receipts.

Collection Overview

Biographical Information:

Amos Chase (1809-1884) was the son of John and Sarah (Hanson) Chase. He lived in Weare, NH, and was the originator of various manufacturing processes. He married Mary Hanson and had two children, John H. and Mary Ann.

John H. Chase (1837-1889) continued to live on the family land in Weare.

Collection Scope and Content Note:

The papers contain mostly business records of Amos Chase, John H. Chase, and Chase & Drew Company in Weare, NH. They include accounts, billing statements, deeds, correspondence, legal documents, receipts, etc.

Arrangement:

The papers have been divided by genre: Legal Papers, Business Correspondence, Accounts/receipts, and Miscellaneous. They are in chronological order within those categories.
