# **Biographical Information**

Ezra Bartlett, the third son of Josiah Bartlett, was a physician from Haverhill, NH. He was a member of the New Hampshire Medical Society, as well as the Chief Justice of Enfield, NH, collector of Internal Revenue for the 5th district of New Hampshire, and state senator. Together with his wife, Hannah Gale, they had eleven children, including two sons, Levi and Josiah, who both attended Dartmouth College.

# Collection Scope and Content

## **Collection Scope and Content Note:**

The Ezra Bartlett papers consist of letters sent to Ezra Bartlett and his family between 1770-1848, as well as several drafts of Bartlett's outgoing correspondence. Family correspondence includes letters written by Bartlett's sister Rhoda True, his wife Mary and their children. Two of Bartlett's sons, Levi and Josiah, wrote letters home while attending Dartmouth College, 1821-1827. The collection also includes letters written by Dr. John French of Landaff, NH from 1808-1844, when he sought medical advice on the use of herbs. They offer valuable insight into early 19<sup>th</sup>-century medical practices, patient symptoms and treatments. The collection also contains printed circular letters from Republican candidates, 1804, and the Concord Infirmary.
