Collection Overview

Biographical Information:

The papers in this collection belonged to:

Daniel Bartlett was born in 1682 in Newbury, MA. His son Daniel Bartlett lived from 1705 to 1786. He had three sons: John, 1733-1798; Daniel, born 1744; Jacob, born 1747. John Bartlett, 1733-1798, was born in Newbury, MA and moved to Chester, NH around 1766. He married Hepzibath Stevens in Chester and then moved to Deering in 1773. Their children were Solomon, John, Jr., Daniel, Lydia, and Hepzibath. Solomon Bartlett married Anna Stevens of Chester, NH, and had 12 children including George. George Bartlett married Polly Bartlett and settled in Deering, NH, where they had Enoch H., Solomon, and Ira.

Collection Scope and Content Note:

The papers in this collection primarily record the financial affairs of this extended family of farmers in the Deering, NH area. Several generations used the books so the material

ranges over almost two centuries, from 1714 to 1893, though the majority of the materials are from the eighteenth and early nineteenth. The accounts include the business matters of buying and selling goods and services, but also noted are births of children, marriage portions of daughters, and an estate inventory of 1797. There are also legal papers such as deeds and an apprenticeship indenture of 1800. Finally, there is an 1890 Fiftieth Wedding Anniversary printed pamphlet for a Warner couple, Mr. and Mrs. Parker Bartlett.

Arrangement:

The materials have been divided by name when that is known. Categories of papers such as deeds are arranged chronologically.
