### BACKGROUND:

The Concord Bank was chartered in 1806. During the early stages of organizing there was a dispute as to the location and management which resulted in the opening of two banks. Both the "Upper" or "North End" and the "Lower" or "South End" used the name Concord Bank. Timothy Walker was President and Samuel Sparhawk cashier of the "Upper" Concord Bank.

At the end of the twenty year charter the "Upper" bank obtained a new charter and took the name Merrimack County Bank. In 1826 the brick building at 174 North Main Street was erected and one tenant was the New Hampshire Historical Society. The bank prospered for forty more years and in 1866, with the expiration of its third charter, in perfect solvency, voluntarily closed its doors.

#### SCOPE NOTE:

The papers in this collection are from the first charter of the Concord Bank. They include vouchers, stock shares, checks and statements that detail the daily operations. There are annual reports and correspondence that give an overview of operations.

Bernard Chase, Capt. Nehemiah Freeman, and Charles Walker have financial papers in the collection. Box five, folder 10 contains bank drafts by Abbot Downing Co. Dec. 1919 to 1920. These are not drawn on the Concord Bank and appear to be unrelated to the collection.
