Introduction

The papers of Frank Rowe Kenison (1907-1980), Chief Justice of the New Hampshire Supreme Court, were arranged to be given to the Manuscripts Division of the New Hampshire Historical Society in 1981 by Judge Kenison himself shortly before his death. The actual transfer of the papers was completed after his death with the cooperation of his wife Loretta, his son Frank, James Gainey (Judge Kenison's former administrative assistant), New Hampshire Historical Society Trustee Richard Upton, and personnel of the Office of Clerk of the Supreme Court.

Processing of the collection was made possible by funding from the Oleonda Jameson Trust of Concord and by personal contributions from members of the New Hampshire legal community.

The collection consists of forty-one Hollinger document boxes or twenty linear feet of shelving. The Case Files begin in 1946 with #3574 and continue through 1973 with #6339.

Scope and Content Note

The Frank R. Kenison Papers at the New Hampshire Historical Society document Frank R. Kenison's years as both Associate and Chief Justice of the New Hampshire Supreme Court covering the years 1945 to 1973.<sup>1</sup>

The collection consists entirely of case files arranged chronologically by their time of filing with the court in original case file or docket number order. The files are fairly complete and include most of the cases for which Judge Kenison wrote either a majority or dissenting opinion. The collection also contains files for most of the "Opinions of the Justices" handed down by the court at the request of the New Hampshire State Legislature or the Governor and Council of the State. These are filed in the same sequence as the case files by case file number.

The files contain various types of documents including memos by other justices on the court such as Amos Blandin, Jr., Laurence Duncan, and Edward Lampron, case briefs with marginalia, research notes, drafts of opinions, and correspondence with other justices, lawyers, government officials, and law professors. Some of these correspondents include Styles Bridges, Archibald Cox, Thomas J. McIntyre, Elwin L. Page, California's Chief Justice Roger J. Traynor, Illinois' Chief Justice Walter V. Schaefer, Justice John Minor Wisdom, Justice Henry J. Friendly, and Erwin N. Griswold. Printed briefs for the cases were removed from the collection unless substantial notes were found in the margins.

Two indices are contained in the register to assist researchers in their use of the collection. The first is an index of Case Names which lists the title of each case in alphabetical order followed by its location in the collection, case file number, and citation to the volume and page of the New Hampshire Reports in which the opinion for the case is published. This index also notes for each case file the initials of each justice, other than Judge Kenison, whose memo or memos are contained in that file. The second index is a Selected Name Index of correspondents whose letters to and from Judge Kenison can be found in the collection.

Frank Rowe Kenison served as Chief Justice for over a quarter of a century, longer than any other person in the state's history. Judge Kenison received special note from his peers for many of his opinions especially in the field of common law. Memos contained in the case files support the claim that Judge Kenison was an innovative jurist who managed to combine his "vital dedication to tradition with creative contributions to the future."<sup>2</sup> More specifically, Judge Kenison's court ruled on several controversial issues of the era including the right to privacy (Hamberger v. Eastman), subversion (Wyman v. Sweezy, Uphaus, and DeGregory), conflict of laws (Clark v. Clark), chemical intoxication testing, and biological proof of paternity.

In addition to the landmark cases the collection's value is greatly enhanced by memos written by the justices and circulated among themselves offering criticism, suggestions, editorial comments, and sometimes humor regarding particular cases. Very often these memos provide a step by step narrative of the strategy and reasoning which went on during the deliberation of each decision, in addition to showing the personal and professional rapport these justices shared while working together.

In its entirety this collection enables the researcher to delve into the every day workings of the court, and to study the judicial decision making process from a vantage point not formerly attainable.<sup>3</sup>
