INTRODUCTION

This collection of Otis Grant Hammond Papers came to the New Hampshire Historical Society in 1977 as a gift from the estate of Hammond's daughter Priscilla.

Otis Grant Hammond (1869-1944) of Concord, N. H. was one of the state's leading figures involved in historical society and library work in the late nineteenth and early twentieth centuries. He served, at various times, as Assistant State Librarian (1896-1913); as Assistant Editor (1890-1915), and later Editor (1933-1943) of the New Hampshire State Papers; and as first director of the New Hampshire Historical Society (1913-1944). He wrote extensively on a variety of subjects, including New Hampshire history, biography, genealogy, and library and historical society operation, while, at the same time, producing several important indexes and bibliographies in the same general subject areas. He edited several volumes of original papers, in addition to the State Papers, and compiled proceedings and other publications for certain of the organizations to which he belonged. (See the classified bibliography of his works which is appended to this register.)

The papers pertain to Hammond's personal, as well as his professional, activities. In addition, the collection contains a small number of personal and business papers produced by other members of the Hammond family, including Otis Hammond's wife, Jessie Anna (Prescott) Hammond (1875-1918) and his daughter, Priscilla Hammond (1900-1977). Material concerning these individuals is, however, fragmentary.

The 740 items included range in date from 1888 to 1963 and consist largely of incoming letters. Also present, however, are newspaper clippings, military orders, lectures, publications, writings in manuscript form and copies of some outgoing letters. The female members of the Hammond family are further represented by notebooks and diaries.

SCOPE AND CONTENT NOTE

The 740 items acquired by the New Hampshire Historical Society from the estate of Priscilla Hammond constitute the largest general collection of Otis Grant Hammond papers known. Ranging in date from 1888 to 1963, the papers document Hammond's personal life and military career as well as his professional activities as librarian, historical society administrator, author and editor. Hammond's wife Jessie and their daughter Priscilla are also represented in the collection.

The papers are arranged in six series as follows:

- I Writings and Lectures, 1888-1940
- II Correspondence about Writings, 1896-1932
- III General Professional Correspondence, 1893-(1902-1933)-1939
- IV Personal Papers, 1896-1944
- V Papers of Other Members of Hammond Family, 1897-1963
- VI Miscellaneous Files, 1894-1947

Series I, Writings and Lectures, includes (1) copies of Otis Hammond's published books and pamphlets which were owned by the Hammond family (one autographed); (2) typescript texts of speeches; (3) clippings of newspaper articles written by Hammond; and (4) his unpublished writings. In the latter category are some of Hammond's earliest attempts at the writing of history, which he produced while at Trinity College. The writings and lectures in this series, which remain for the most part unpublished, reflect Hammond's concern with a variety of topics ranging from "Camp Discipline" to "Old Glass."

Series II, Correspondence About Writings, records the various steps in the production of Hammond's publications, including preliminary arrangements, research, printing, and distribution. Valuable criticism and commentary on his works is provided by the numerous letters of acknowledgment from libraries and individuals sent copies of his publications. Approximately one-third of the letters in this series relate to Hammond's work as Assistant Editor of the N. H. State Papers. The series also contains important information

about several proposed publications which never materialized, including a volume of <u>State Papers</u> for which the transcripts survive at the N. H. Historical Society.

Series III, General Professional Correspondence, consists of all letters relating to Hammond's professional life, except those directly involved with his publications. The letters in this series chronicle the several steps in Hammond's career, including his early unsuccessful attempts (1910-1912) at becoming librarian of the N. H. Historical Society and his rejection of two eminent positions offered him (1909, 1929).

This series also provides evidence of the wide range of Hammond's activities as Assistant State Librarian (before 1913) and as administrator of the N. H. Historical Society (1913 on). For both time periods, the letters provide evidence of Hammond's continuous attempts to build his institution's book and manuscript collections, to find appropriate repositories for duplicate and irrelevent materials, and to help researchers around the country with historical and genealogical inquiries. During the earlier period, the letters also include material related to Hammond's trip to Halifax (1909) in search of missing colonial documents. After 1913, when the functions of a museum administrator were added to the librarian's duties to which he was accustomed, Hammond's papers reflect his apparently deliberate attempts to increase the Society' membership and to retain the favor of the Society's major benefactor Edward Tuck. Letters regarding the N. H. Historical Society's museum collections are relatively few, but may be important in suggesting that Hammond played a more active role in library than in museum development.

Series IV, Personal Papers, documents Hammond's role in the various social communities of which he was a part, as well as providing some evidence about his personal and financial affairs. In addition to general correspondence,

this series includes papers related to Hammond's involvement with the military, with Trinity College, with the family business (Concord Iron Foundry), and with various social and cultural organizations—namely, Freemasonry, the Newcomen Society, the Protestant Episcopal Church, the Sons of the American Revolution, and the Wonolancet Club of Concord. This series is important in providing evidence that Hammond's productivity was not restricted to his professional activities. The papers included here record Hammond's helping to set up a library for the Wonolancet Club, collecting information for the Sons of the American Revolution about the location of revolutionary soldiers' graves, supervising the design and production of a diocesan seal, and writing to congressmen about various bills in which he had an interest.

Series V, Papers of Other Members of the Hammond Family, contains items either produced or received by Otis Hammond's wife, Jessie Anna (Prescott) Hammond (1875-1918) or by their daughter Priscilla Hammond (1900-1977). The papers of Jessie and Priscilla Hammond are fragmentary in nature, perhaps because they tend to be those papers which relate closely to Otis Hammond as well.

Jessie Hammond's papers (1897-1898) include letters relating to her engagement and marriage and a diary covering the first months that her husband served in the N. H. Volunteers during the Spanish American War. The papers of Priscilla Hammond (1919-1963) found here relate, with one exception, either to her father's death or to the family business (The Concord Iron Foundry), in which she was involved from the time of her father's death until she sold the controlling interest in 1963.

Series VI, Miscellaneous Files, is composed of two distinct parts:

1) letters of which Hammond was neither the author nor the recipient (These letters do not relate to papers in the other series, but may

have been sent to Hammond as enclosures.);

2) newspaper clippings preserved in Hammond's family and relating to various aspects of his personal and professional life. (The clippings are a valuable reference tool serving to elucidate other portions of the collection; they are mostly from Concord, Boston and New York newspapers.)

The internal arrangement of each of the above series is described in an introductory statement, unless the arrangement is considered self-explanatory. The introductions to individual series also offer cross-references to related papers and suggestions to facilitate use of the material.

Some particulars of arrangement apply to all series. Undated items are always filed after related material bearing dates. Copies of outgoing letters are filed in chronological order with incoming letters belonging to the same category. Letters of which Hammond is neither author nor recipient are assumed to have been enclosures and filed with related material if any survives; otherwise, they are placed in Series VI, Miscellaneous Files.

As the arrangement within the series is usually chronological, the following lists are included in order to provide some access by correspondent.

Even though this is the largest general collection of Otis Hammond papers known, it is by no means complete. Inexplicably, some years receive better coverage than others; the years 1904-1905, for example, are almost entirely unrepresented. The absence of files of outgoing letters further affects the completeness of the collection; copies of only five of Hammond's own letters are included. (For these letters, see Series III, Folders 6, 11, 17, and Series IV, Folders 7 and 12.)

Fortunately, several additional manuscript collections at the N. H. Historical Society supplement the papers received from Priscilla Hammond's estate. Some of these are:

- (1) the papers (1 box) received in 1963 from Marcus McCorison, librarian of the American Antiquarian Society (this is a general collection of personal and professional papers similar to that received from Priscilla Hammond);
- (2) the "N. H. Historical Society Archives," containing official correspondence and typescripts of annual reports presented by Hammond, 1914-1943 (some of the correspondence is filed in a special series on the N. H. Historical Society's building);
- (3) "Otis G. Hammond Papers--Transcripts" (2 boxes), containing transcripts of documents in English archives intended for publication in a volume of State Papers which never materialized); 1977-55 box 7+8
- (4) "Otis G. Hammond Papers--Transcripts--Loyalists" (2 boxes of material compiled by Hammond in his work on "The Tories of New Hampshire");
- (5) "Edward Tuck Papers," containing three folders of letters from Tuck to Hammond, 1916-1937.

The documentary evidence at the N. H. Historical Society is supplemented by artifact collections relating to Otis Hammond. One hundred and forty-five items, including photographs, silhouettes, medals and a military uniform, were acquired for the museum collections from the estate of Priscilla Hammond. A listing of these items is available upon request.

To summarize, although this is the largest general collection of Otis Hammond's papers known, it cannot be used effectively without reference to other resources available at the N. H. Historical Society and listed above.

CORRESPONDENCE ABOUT WRITINGS

The letters dealing with the <u>N. H. State Papers</u> are filed separately from those relating to Hammond's other publications. The <u>State Papers</u> correspondence contains numerous enclosures sent to Assistant Editor Hammond by Editor Albert S. Batchellor. In order to clarify the sequence of events, most of these enclosures have been filed chronologically by their original dates rather

Anyone interested in these letters should also examine the transcripts themselves which constitute a separate manuscript collection at the New Hampshire Historical Society.

than with the letters in which they were enclosed.

These papers include photographs, sales catalogs, orders and notices, as well as correspondence. They have been divided into subsections related to various aspects of Hammond's personal and social life, as follows:

- 1) Social and Cultural Organizations
- 2) Education and Educational Institutions
- 3) Military
- 4) Business
- 5) Personal, Family and Financial Matters.

The first subsection is arranged alphabetically by the names of specific organizations. The third and fourth categories are organized internally by the form of material. The other two sections are ordered chronologically.

The Otis Hammond Papers given to the N. H. Historical Society by Marcus McCorison contain additional material about Hammond's involvement with the National Guard and the Sons of the American Revolution and may also provide further information about other aspects of his personal life.

Additional material regarding Hammond's personal life is to be found in Series V with the papers of his wife and daughter, particularly in connection with his marriage (wedding invitation, etc.) and his death (condolences to daughter), and in the connection with the Spanish American War era, during which his wife kept a diary.

Series I (Writings and Lectures) also includes material relating to Hammond's personal life: lectures on military subjects, papers written at Trinity College and the prophecy which he wrote for his high school class.

There is routine correspondence when Hammond was secretary of the New Hampshire Historical Society and as deputy Secretary of State. His army papers include passes and his discharge. The 5th NH papers describe controversy over the Gettysburg monument, reunions and the history of the regiment.

Stevens (1833-1902), a bibliographer in London who did much work for American institutions and who published facsimilies of documents important to American History. (See Who Was Who in America). He was probably responsible for the transcripts listed above.

It was intended to publish a complete set of transcripts, that is all the documents which had not been published before, in a set of the State Papers. This was ordered by the Governor in 1901, but was never done.
