Abstract:

Natt Head served as Adjutant-General, Governor, and President of the Senate of New Hampshire. The papers contain items related to Natt Head's law practice, the family brick business, Head and Dowst, and lots of genealogical materials. There is little relating to his term as Governor of New Hampshire or Adjutant-General.

Collection Overview

Biographical Information/ Administrative Information:

Nathaniel Head was born on May 20, 1828 in Hooksett, NH. He officially changed his name from Nathaniel to Natt on September 15, 1875. Head worked as a construction material supplier, farmer, and politician. He was married to Abbie M. Stanford. From 1864 to 1870, Head served as the Adjutant General of New Hampshire. He then was a member of the State Senate in 1876 and 1877, acting as President of the State Senate in 1877. He subsequently was elected Governor and held the office from 1879 to 1881. Head died in Hooksett on November 12, 1883.

Collection Scope and Content Note:

The Natt Head Papers, 1743-1958, contain items related to Natt Head's law practice, the family brick business, Head and Dowst, and lots of genealogy. There is little relating to his term as Governor of New Hampshire or Adjutant-General. The collection includes deeds, correspondence, estate papers, legal documents, photographs, and record books. Head's name change document is also found in the collection. There is an unidentified

diary dated from January 1876 to April 1878. Materials in the collection also cover members of Natt Head's family.
