BIOGRAPHICAL NOTE:

Capt. Moses Hoit (1733-1853) m. Betsy Dole, of S. Hampton, Nov. 1, 1810) He taught school many years in different towns in NH and Mass., 12 years in succession in Salisbury Point, MA; was Capt. of the 9th U.S. Infantry company in the war of 1812; afterwards lived at Derry, NH.

Moses French Hoit (1813-) m. Marianna Hatch, of Greenland, NH Sept. 10, 1844. He graduated from Dartmouth College in 1835; taught some time, commenced the practice of law at Livingston, Ala. in 1839; removed to Nevada, California in 1850, was the first mayor of that city.

SCOPE AND CONTENT NOTE:

Capt. Moses Hoit is represented by papers concerning his service and pension from the war of 1812. Also included is a speech he gave in 1804 defending President Jefferson. Moses French Hoit married Marianna Hatch, sister of Albert R. Hatch and there are three letters from Hatch regarding personal matters and containing some political content.
