UPTON, Robert William, 1884-1972

UPTON, Robert William, a senator from New Hampshire; born in Boston, Mass., February 3, 1884; son of Mark and Clara Upton, attended New Hampshire public schools; graduated from Boston University Law School in 1907 admitted to the Massachusetts and New Hampshire bars in 1907 and commenced practice in Concord, N.H.; married Martha G. Burroughs September 18, 1912; six children; Richard F., Elise Wright, Frederic K, Allan E., George T., and John T.; member, State House of Representatives 1911; delegate to the New Hampshire State Constitutional Conventions in 1918, 1930, 1938, and 1948, serving as president in 1948; appointed as a Republican to the United States Senate to fill the vacancy caused by the death of Charles W. Tobey, and served from August 14, 1953, to November 7, 1954; unsuccessful candidate for nomination to fill the vacancy; resumed law practice; retired from law practice in 1970; died Concord, N.H., April 28, 1972; interment in Blossom Hill Cemetery.
