Collection Overview

Biographical Information/ Administrative Information:

Nathan Waldo Sr. was one of the original proprietors of Orange, NH. His son, Nathan Waldo Jr. (1767-1832) was practicing law in Canterbury, CT. He was ordained in 1806 and preached in Williamstown, VT until he returned to Orange, NH in 1825. In 1830, he moved to Haverhill, MA where he died in 1832. Nathan Waldo's sister Abigail Waldo married Benjamin Wood Jr. (1777-1842). Three of their children were Benjamin Payne Wood, Horace Wood, and Gilbert Wood.

Benjamin Payne Wood (1807-) was raised in Orange and East Alstead, NH. He married Matilda E. Carter of Cornish, NH. In his early years he tried his hand at wall building and later appears to have worked with mechanical equipment.

Horace Wood (1810-1886) studied at Kimball Union Academy and graduated from Gilmanton Theological Seminary in 1838. He was ordained in 1839. He served in many places in New Hampshire including Dalton, Whitefield, Gilmanton, Centre Ossipee, Gilsum, and Keene, as well as Winslow, Maine. He married Mehitable Gale of

Gilmanton, in 1839. She died in 1849 and he married Sarah Ann Greene of Winslow, ME in 1849.

Gilbert Wood (1822-1850) began his career as a teacher in Gilsum, NH in 1842. In 1846 he also became a daguerreotypist. He died of illness in 1850 at 28 years old.

Collection Scope and Content Note:

The Horace Wood Family Papers, 1806-1868, contains the papers of Reverend Nathan Waldo, Horace Wood, Gilbert Wood, and Benjamin Payne Wood. The collection is organized into five series, relating to each of the men. The collection includes personal correspondence, sermons, notes, essays, and diaries.

Scope and Content: Horace Wood's letters to his family include subjects such as his career as a school teacher and preacher, concerns for ill & poor, use of *Brown's Bronchial Troches* and prohibitory liquor laws. The notes from Gilmanton Theological Seminary cover such topics as how to deliver sermons and habits of minister. His essays cover various topics including the rights of Indians, the manufacture of alcohol, and the life of Cicero. There are also two account books of the Temperance Society from 1868.

Scope and Content: Gilbert Wood's correspondence covers family activities and health and touches on his writing schools and photography miniatures. His diary entries include mention of vaccination for H pox, snow storms, letters sent and received, and going and returning from schools. He also was apparently interested in phrenology as shown by the booklet and chart on the subject.
